<b>INSURANCE</b>	The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. <b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations are requested to bear international flights for their delegation members (see exception herein below). The travel schedule form must be sent to the LOC by <b>31<sup>st</sup> October, 2013</b>.</p> <p>The LOC will cover international flights for the Medalists from the 44<sup>th</sup> World Artistic Gymnastics Championships in Antwerp 2013 and their respective coach only.</p>																		
<b>LOCAL TRANSPORTATION</b>	<p>Local transportation between Chubu Centrair International Airport in Nagoya or Nagoya Station and the official hotel will be provided by the LOC for all official delegation members.
