<b>INSURANCE</b>	<p>The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation (except for gymnasts with a valid FIG licence and judges with valid FIG brevet – according to the Contract Extract FO 0115 00 A/2.5.2 published on FIG Intranet, Insurance, Insurance terms Athletes and Judges)</p> <p>The OC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the OC in advance.</p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p><b>The invited participating federations must pay for the travel costs of their delegation members.</b></p> <p>The Travel Schedule Form must be returned to the OC by <b>October 20<sup>th</sup> 2014.</b></p>

If cancelled less than one week prior the competition, 40% will be deducted. If the cancellation is during the reservation, there is no reimbursement.</p>																				
<b>MEALS</b>	<p>Boarding is included in the payment.</p> <p>Cancellation/Reimbursement Policy:</p> <p>If the reservation is cancelled more than one week before the competition, 20% of the payment will be deducted. If cancelled less than one week prior the competition, 40% will be deducted. If the cancellation is during the reservation, there is no reimbursement.</p>																				
<b>FINAL BANQUET</b>	<p>The Final Banquet will take place after the competition in Bowling (below the Gymnastic Hall).</p> <p>Only for participants (coaches, judges, competitors).</p>																				
<b>JUDGES AND JURIES</b>	<p>In case of participation of a team, it is obligatory to send 2 FIG judges with current valid brevet. In case of participation of 2 individuals, it is obligatory to send 1 FIG judge with current valid brevet. For each missing judge the penalty will be 200€.</p>
