<b>FEDERATIONS INVITED AND REPLACEMENT POLICY</b>	<p>The organizing member federation may invite FIG member federations in good standing at their discretion, but must invite at least all Member Federations who had gymnasts:</p> <ul style="list-style-type: none"> <li>- ranked 1-8 in C-III at the previous World Championships*</li> <li>- ranked 1-8 from the 2014 World Cup Ranking List for Individual Apparatus</li> </ul> <p><i>* For the 2015 series, the gymnasts' invitation will be based on the results of the 2014 World Championships</i></p>																																
<b>PARTICIPATION AND FIG LICENSE</b>	<p>Only senior gymnasts in good standing with the correct age and holding a valid FIG License may participate. The Organizing Committee will be responsible for checking the validity of the gymnasts' licenses. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration. <b>COMPETITION FORMAT</b>	<p data-bbox="475 651 1527 719">The Individual Apparatus Competitions for World Challenge Cup competitions consist of:</p> <p data-bbox="475 719 948 752">Qualifications and Apparatus Finals</p> <p data-bbox="475 752 668 786"><u>Qualifications:</u></p> <ul data-bbox="475 786 1527 1424" style="list-style-type: none"> <li>▪ Participation is limited to 2 gymnasts per country on each apparatus.</li> <li>▪ The Organizing Member Federation is allowed to add (only for the qualifications) “hors concours” competitors. These competitors are in addition to the official competitors of the Organizing Member Federation, they must be named at the time of the closing of the nominative registration and they cannot qualify for the Finals. They are not eligible to receive World Cup points, they must not appear on the official results lists and they will have to start first at every apparatus.</li> <li>▪ The Organizing Member Federation is allowed to name a max. of “4 hors concours” competitors in Women’s Artistic Gymnastics and a max. of “4 hors concours” competitors in Men’s Artistic Gymnastics for a total of 8 “hors concours” gymnasts (i.e. while one “hors concours” gymnast can compete on more than one apparatus, not more than one “hors concours” gymnast can compete on an apparatus).</li> <li>▪ FIG Competition III rules will be applied for vault.</li> <li>▪ In case of a tie at any place, the tie-breaking rules as set up for the World Championships shall be applied. Not more than one judge per Federation per panel will be permitted (except for time and line judges).</p> <p>The judges' panels are set up by a draw from the judges present at the event. The draw must be directed by the MAG and WAG Technical Delegates. The participating member federations must send minimum one qualified judge for MAG if they participate with male gymnasts and one qualified WAG judge if they participate with female gymnasts.</p> <p>The Organizing Member Federation will apply a fine of CHF 2'000 per missing judge (to be paid to the LOC) should a federation fail to bring the required number of judges. This fine must be paid to the LOC by 23/02/2015.</p> <p>The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the on-line nominative registration, the Organizing Member Federation must propose to the FIG for approval the name of neutral additional judges to complete the panels (plus 2 reserves, 1 man and 1 woman). These judges, once approved, have to be invited at the cost of the Organizing Member Federation. Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the TC Presidents concerned will invite these judges at the cost (in terms of international and local travel, accommodation and meals) of the Organizing Member Federation. <p><b>VIDEO CONTROL SYSTEM</b></p>	<p>Should IRCOS not be available, the Organizing Member Federation will provide another video control system which allows to treat inquiries and records all exercises of the competition in a quality which allows to judge the exercises.</p>

In case that less than four federations participate per apparatus, no World Cup Points, no medals and no prize money will be given.

**WINNER OF THE ANNUAL INDIVIDUAL APPARATUS WORLD CUP SERIES**

The winner of the annual Individual Apparatus World Cup and World Challenge Cup Series is the gymnast with the highest number of points for each apparatus after the last event of the year as follows:

- If 5 or more World Cup Competitions take place per year, the best 4 are counted
- If 4 or 3 World Cup Competitions take place per year all points are counted

A special award ceremony must be held at the last Individual Apparatus World Cup/World Challenge Cup competition of the year in which the Individual Apparatus World Cup and World Challenge Cup winners shall receive a Cup.

In case of a tie in the respective World Cup Ranking Lists after the last respective competitions of the year, the tie will not be broken.
